## 3. For what purposes and on what legal basis is the data processed?

We process this data in accordance with the regulations of the General Data Protection Regulation (GDPR) and the Federal Data Protection Act 2018, as amended, in order to safeguard legitimate interests pursuant to Art. 6 (1) lit. f GDPR.

## 4. Who receives my data?

If we use a service provider (e.g. photographers) in the sense of order processing, we remain nevertheless responsible for the protection of your data. All contract processors are contractually obliged to treat your data confidentially and to process it only within the scope of the provision of services.

The photos taken of you may be published and used by us in the following media:

## 6. How long is my data stored?

We store your data only until the fulfillment of its purpose, or until you revoke your consent to use. Afterwards these are to be deleted according to GDPR.

## 7. What data protection rights do I have?

You have the right at any time to information, correction, deletion or restriction of the processing of your stored data, a right of objection to the processing as well as a right to data transfer and complaint in accordance with the requirements of data protection law.
